## Additional Explanations

At today's Board of Directors Meeting of our Company, it has been unanimously decided that

1. In accordance with the provisions of the Capital Markets Board's Registered Capital System Circular No. II-18.1, the increase of our company's current Registered Capital Ceiling of 500,000,000 (five hundred million) Turkish Liras to 10,000,000,000 (ten billion) Turkish Liras,
2. To extend the validity period of the Company's registered capital ceiling for a new five-year period valid for 2026-2030, as the current validity period expires at the end of 2025.
3. In this context, to approve the attached amendment text regarding the planned change to Article 10, titled "Capital," of our Company's Articles of Association, within the framework of Turkish Commercial Code No. 6102, Capital Markets Law No. 6362, and other relevant legislation,
4. To apply to the Capital Markets Board and the Ministry of Trade for the necessary permits and approvals for the aforementioned amendment text,
5. Following the receipt of the necessary permits and approvals, to submit the amendment to the Articles of Association to our shareholders for approval at the next General Assembly meeting,
6. To make the necessary announcements within the framework of the Capital Markets Board's regulations on special circumstances,

The relevant amendment text is provided in the attachment.
